Sub: Investment in a Special Purpose Vehicle (SPV) for supply of 15.50 MWp Ground Mounted Solar Power to the Company and/or any of its subsidiaries.

As a part of ESG journey, please take note that the Company has today agreed to make investment in Bhargavi Renewable Private Limited, ("BRPL"), a subsidiary of Welspun Renewable Energy Private Limited ("WREPL"), a related party of the Company.

The Company agreed to make an investment not exceeding Rs.3.50 Crore holding upto ~22.67% equity share capital in BRPL. The Company and/or its subsidiaries propose to enter in Power Purchase Agreement (with Take or Pay arrangement) for supply of renewable power for a period of 25 years and will pay interest free security deposit upto ~Rs. 1.85 crore.

The above is in compliance with Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 and the Company's Code of Practices and Procedure for Fair Disclosure of Unpublished Price Sensitive Information.
