Further to our disclosure dated 20<sup>th</sup> March 2025 pertaining to induction of a strategic investor with 74% equity shares in wholly-owned subsidiary viz. Nauyaan Shipyard Private Limited (NSPL), we are now pleased to inform you that the transaction has been completed today and the Company has received Rs. 476.39 Crores. Consequently, NSPL has ceased to be a subsidiary of the Company and has become an Associate of the Company effective today.

The Company plans to utilise surplus cash including existing Treasury to reduce Debt, and to pre-pay a total of around Rs. 1,000 crores of Debt before 31<sup>st</sup> March’25. As a part of this plan, the Company has today pre-paid Debt of Rs. 725 Crores and will continue to focus on further reduction of Debt and Finance costs.

As on 31<sup>st</sup> December 2024, the Company’s Consolidated Net Debt was already at a minimal level of Rs. 104 Crores.

After today’s transaction, the Company is in a Consolidated Net Cash position.
