We are pleased to inform that Welspun Corp Ltd. (WCL), since our last announcement on May 27, 2022, has secured various orders to be executed from India and the USA across the Oil & Gas and Water sector, of ~47,000 MT amounting to ~INR 600 Crores.

These include, receipt of an order for the supply of onshore coated pipes and bends for a pipeline project in Australia. This is a prestigious order for the manufacture and supply of ~19,700 MT of pipes and 180 bends for transportation of gas. This export order will be executed from WCL's plant at Anjar, India in H2 FY22-23. The challenging specifications of the pipes to be supplied, shows the confidence of the customers on WCL's engineering quality and technical excellence.

This will be the fourth order from Australia that WCL has won in the recent past.


